Oral intake : Do not administer sodiumbicarbonate to neutralise. This can cause CO₂ gas formation which can lead to perforation of the stomach. Slowly drink aluminiumoxide (Al₂O₃) suspended in water.

In cases of irritation to the lungs, initial treatment with Dexamethason metered aerosol.
Treat symptomatically. An eyewash is recommended in the immediate work area.
